

HOUSE LOCAL BILL NO. 19-14, D1

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE FIRST SENATORIAL DISTRICT**

To appropriate funds in the amount of \$22,050.00 specifically allotted to the First Senatorial District under Public Law No. 18-30; and for other purposes.

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE
COMMONWEALTH CODE:**

1 **Section 1. Findings and Purpose.** The purpose of this Act is to appropriate funds in the
2 amount of \$22,050.00 specifically allotted to the First Senatorial District under Public Law No. 18-30.

3 **Section 2. Appropriation.** The Rota Legislative Delegation hereby appropriates the Twenty
4 Two Thousand and Fifty US Dollars (\$22,050.00) of the funds allotted to the First Senatorial District
5 under Public Law No. 18-30 for tourism enhancement activities and for other purposes:

6	a) Luta Agricultural Fair	\$ 5,000.00
7	b) Restoration of Tourist Sites	\$ 5,000.00
8	c) Pona Point Railing Project	<u>\$12,050.00</u>
9	TOTAL:	<u>\$22,050.00</u>

10 **Section 3. Reporting.** Each respective expenditure authority shall submit to the Chairperson
11 of the Rota Legislative Delegation a detail report showing the expenditure of the funds at the
12 completion of appropriations in Section 2 of this Act.

13 **Section 4. Fund Distribution.** Funds appropriated under Section 2 of this Act shall be
14 distributed accordingly to the intended purpose and/or entity upon this Act becoming law.

15 **Section 5. Expenditure Authority.** The expenditure authority of the funds appropriated
16 under this Act shall be the Mayor of Rota.


House Local Bill No. 19-14, D1

1 **Section 6. Severability.** If any provision of this Act or the application of any such provision
2 to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder
3 of this Act or the application of its provisions to persons or circumstances other than those to which it is
4 held invalid shall not be affected thereby.


5 **Section 7. Savings Clause.** This Act and any repealer contained herein shall not be construed
6 as affecting any existing right acquired under contract or acquired under statutes repealed or under any
7 rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any
8 proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect
9 of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in
10 existence on the date this Act becomes effective.

11 **Section 8. Effective Date.** This Act shall take effect upon its approval by the Governor or its
12 becoming law without such approval.
