#### A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE FIRST SENATORIAL DISTRICT

To appropriate funds in the amount of \$22,050.00 specifically allotted to the First Senatorial District under Public Law No. 18-30; and for other purposes.

#### BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

Section 1. <u>Findings and Purpose</u>. The purpose of this Act is to appropriate funds in the amount of \$22,050.00 specifically allotted to the First Senatorial District under Public Law No. 18-30.

Section 2. <u>Appropriation</u>. The Rota Legislative Delegation hereby appropriates the Twenty Two Thousand and Fifty US Dollars (\$22,050.00) of the funds allotted to the First Senatorial District under Public Law No. 18-30 for tourism enhancement activities and for other purposes:

c)	Pona Point Railing Project	<u>\$12,050.00</u>
b)	Restoration of Tourist Sites	\$ 5,000.00
a)	Luta Agricultural Fair	\$ 5,000.00

10 Section 3. <u>Reporting</u>. Each respective expenditure authority shall submit to the Chairperson 11 of the Rota Legislative Delegation a detail report showing the expenditure of the funds at the 12 completion of appropriations in Section 2 of this Act.

Section 4. <u>Fund Distribution</u>. Funds appropriated under Section 2 of this Act shall be
 distributed accordingly to the intended purpose and/or entity upon this Act becoming law.

15 Section 5. <u>Expenditure Authority</u>. The expenditure authority of the funds appropriated
16 under this Act shall be the Mayor of Rota.

#### House Local Bill No. 19-14, D1

Section 6. <u>Severability.</u> If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

Section 7. Savings Clause. This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

Section 8. Effective Date. This Act shall take effect upon its approval by the Governor or its becoming law without such approval. 12
