

House Local Bill No. 19-36, D1

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE FIRST SENATORIAL DISTRICT**

To appropriate the Bond Interest Income Earned collected for the First Senatorial District in the amount of Twenty-Eight Thousand Dollars (\$28,000.00 USD).

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION
PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1
OF THE COMMONWEALTH CODE:**

1 **Section 1. Findings and Purpose.** The purpose of this Act is to appropriate the Bond
2 Interest Income Earned collected for the First Senatorial District in the amount of Twenty-
3 Eight Thousand dollars (\$28,000.00 USD) for the Poña Point Railing Project that has been
4 identified by the Commonwealth Development Authority as available for appropriation.

5 **Section2. Appropriation.** Notwithstanding any provision of law to the contrary, the
6 Rota Legislative Delegation hereby appropriates the Bond Interest Income Earned collected for
7 the First Senatorial District in the amount of Twenty-Eight Thousand Dollars (\$28,000.00
8 USD) for the Poña Point Railing Project.

1 **Section 3. Expenditure Authority.** The expenditure authority of the funds
2 appropriated and earmarked under this Act shall be the Mayor of the First Senatorial District.

3 **Section 4. Fund Balance.** Notwithstanding Section 4, any fund balance may be
4 reprogrammed by the Mayor of the First Senatorial District for the purpose of funding any
5 capital improvement project.

6 **Section 5. Reprogramming.** Notwithstanding any laws, provisions or regulations to
7 the contrary, funds appropriated and earmarked under this Act shall not be reprogrammed for
8 any other purpose unless through legislative appropriation.

9 **Section 6. Severability.** If any provisions of this Act or the application of any such
10 provision to any person or circumstance should be held invalid by a court of competent
11 jurisdiction, the remainder of this Act or the application of its provisions to persons or
12 circumstances other than those to which it is held invalid shall not be affected thereby.


13 **Section 7. Savings Clause.** This Act and any repealer contained herein shall not be
14 construed as affecting any existing right acquired under contract or acquired under statutes
15 repealed or under any rule, regulation, or order adopted under the statutes. Repealers
16 contained in this Act shall not affect any proceeding instituted under or pursuant to prior law.
17 The enactment of the Act shall not have the effect of terminating, or in any way modifying,
18 any liability, civil or criminal, which shall already be in existence on the date this Act becomes
19 effective.

1 Section 7. Effective Date. This Act shall take effect upon its approval by the
2 Governor, or its becoming law without such approval.
