**A LOCAL APPROPRIATION BILL FOR AN ACT
 FOR THE FIRST SENATORIAL DISTRICT**

To appropriate \$165,880.00 from the funds specifically allotted to the First Senatorial District under Public Law No. 18-56, inclusive of the funds line-item vetoed under Rota Local Law 20-08, to fund the Micronesian Legal Services Corporation extension office in Rota; operations of the Rota Legislative Delegation; Rota Flame Tree program, Rota Little League program, Office of the Mayor of Rota; and the Rota Municipal Council; and for other purposes.

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION
 PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1
 OF THE COMMONWEALTH CODE:**

1 SECTION 1. FINDINGS AND PURPOSE.

2 The Rota Legislative Delegation acknowledges that the Micronesian Legal Services
 3 Corporation (MLSC) is a non-profit corporation that provides low income persons free legal
 4 assistance in civil matters. MLSC's mission is to promote equal access to justice and to provide
 5 quality civil matter assistance to indigents.

6 The Rota Legislative Delegation also acknowledges that the MLSC's central
 7 administrative office is located in Saipan and only a couple visits are made annually to Rota.
 8 The Delegation finds that it is necessary to have an extension office in Rota so that indigents can
 9 have better access to the services provided by MLSC rather than flying to Saipan or wait for the
 10 MLSC's scheduled annual visit. The Delegation finds it necessary to fund an MLSC extension
 11 office in Rota.

1 Additionally, HLB 20-55, S1 was signed into law as Rota Local Law 20-08 but two items
2 were line-item vetoed. The Governor vetoed Section 2(j) because it failed “to delineate the
3 particular purpose for this operational funding.” And Section 2(r) was vetoed because it failed
4 to describe a specific purpose for the funds and thus violates the “Public Purpose statute.”

5 The Rota Legislative Delegation Chairperson sent a letter dated March 13, 2018
6 requesting a specific explanation of the vetoed items, but has not received a response. The
7 Delegation finds that operational funds for the Saipan and Northern Islands Legislative
8 Delegation (SNILD) and the Tinian and Aguiguan Legislative Delegation (TALD) had been
9 approved without delineating the particular purpose for the operational funding. In fact, the
10 SNILD \$139,000.00 appropriation under Saipan Local Law 20-18 did not state the purpose of
11 the appropriation and it was approved. Similarly, the appropriation of \$20,000.00 for the
12 operations of the TALD was also approved under Tinian Local Law 20-9.

13 The Delegation finds that, based on prior approved appropriations with identical or
14 similar language and at least one appropriation without any stated purpose at all were approved,
15 the appropriations with stated public purposes in this Act should be approved.

16 The purpose of this Act is to appropriate \$165,880.00 of the funds specifically allotted
17 to the First Senatorial District under Public Law No. 18-56 to fund the Micronesian Legal
18 Services Corporation extension office in Rota, Rota Legislative Delegation operations, Rota
19 Flame Tree program, Rota Little League program, Office of the Mayor of Rota, and the Rota
20 Municipal Council.

21 **SECTION 2. APPROPRIATIONS.**

22 The amount of \$165,880.00 of the funds allotted to the First Senatorial District under
23 Public Law No. 18-56, inclusive of the funds line-item vetoed under Rota Local Law 20-8, is
24 appropriated for the following:

- 25 a) \$30,000.00 for the Micronesian Legal Services for its extension program on Rota
26 and the funds shall be used for office space rental, salary of an office
27 administrator, office operations and related costs. The expenditure authority is
28 the Director of the Micronesian Legal Services Corporation.

- 1 b) \$70,880.00 for any lawful public purpose operation activities of the Rota
- 2 Legislative Delegation under the expenditure authority of the Chairman of the
- 3 Rota Legislative Delegation;
- 4 c) \$20,000.00 for the operations of the Office of the Mayor of Rota under the
- 5 expenditure authority of the Mayor of Rota;
- 6 d) \$10,000.00 for the Rota Flame Tree program under the expenditure authority of
- 7 the Resident Director of the Department of Community and Culture Affairs;
- 8 e) \$10,000.00 for the Rota Little League program under the expenditure of the
- 9 President of the Rota Little League Association; and
- 10 f) \$25,000.00 for the operations of the Rota Municipal Council under the
- 11 expenditure authority of the Chairman of the Rota Municipal Council.

12 **SECTION 3. NO REPROGRAMMING AND FUNDS AVAILABLE UNTIL**
 13 **EXPENDED.**

- 14 a) The appropriations under this Act are not subject to fiscal year limitation and shall
- 15 be available until fully expended.
- 16 b) The funds shall not be reprogrammed for any other purpose.

17 **SECTION 4. SEVERABILITY.**

18 If any provision of this Act or the application of any such provision to any person or

19 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this

20 Act or the application of its provisions to persons or circumstances other than those to which it

21 is held invalid shall not be affected thereby.

22 **SECTION 5. SAVINGS CLAUSE.**

23 This Act and any repealer contained herein shall not be construed as affecting any

24 existing right acquired under contract or acquired under statutes repealed or under any rule,

25 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect

26 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not

27 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which

28 shall already be in existence on the date this Act becomes effective.


1 **SECTION 6. EFFECTIVE DATE.**
