

HOUSE LOCAL BILL NO. 18-51, D1

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To appropriate the associated interest of Two Million Seven Hundred Seventeen Thousand Nine Hundred Sixty Nine US Dollars (\$2,717,969.00) in bond funds for capital improvement related projects for the Third Senatorial District; and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION

PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1

OF THE COMMONWEALTH CODE:

1 **Section 1. Purpose.** The purpose of this Act is to appropriate the Two Million Seven
2 Hundred Seventeen Thousand Nine Hundred Sixty Nine US Dollars (\$2,717,969.00) in bond
3 funds for capital improvement related projects for the Third Senatorial District that had been
4 identified by the Honorable Governor Eloy S. Inos in Governor's Communication No. 18-25
5 to the Chairman of the Saipan and Northern Islands Legislative Delegation.

6 **Section 2. Appropriation.** Notwithstanding any provision of law to the contrary, the
7 Saipan and Northern Islands Legislative Delegation hereby appropriates the amount of Two
8 Million Seven Hundred Seventeen Thousand Nine Hundred Sixty Nine US Dollars
9 (\$2,717,969.00) for the following capital improvement related projects within the Third
10 Senatorial District:

- 11 a) The amount of \$250,000.00 for the Commonwealth Health Care
12 Corporation to purchase new beds for the Commonwealth Health Center;

1 b) The amount of \$250,000.00 for the Public School System for the
2 purchase of two new 66-passenger school buses for PSS;

3 c) The amount of \$400,000.00 for Precinct I for various capital
4 improvement related projects within Precinct I;

5 d) The amount of \$380,000 for Precinct II for various capital
6 improvement related projects (infrastructure development projects) within
7 Precinct II;

8 e) The amount of \$450,000.00 for Precinct III for the construction of a
9 small amphitheater and related facilities at the Carolinian Utt and for various
10 capital improvement related projects (roads and drainage projects) within
11 Precinct III;

12 f) The amount of \$273,969.00 for Precinct IV for various capital
13 improvement projects within Precinct IV;

14 g) The amount of \$600,000.00 for Precinct V for various capital
15 improvement projects (Kagman road paving projects) within Precinct V.

16 h) The amount of \$100,000.00 for the Mayor of Saipan for the purchase
17 of heavy equipment; and

18 i) The amount of \$50,000.00 for the Saipan Southern High School
19 baseball field.

20 **Section 3. Expenditure Authority.** The expenditure authority of the funds
21 appropriated under this Act shall be the Secretary of the Department of Public Works.

22 **Section 4. Reprogramming.** Notwithstanding any laws, provisions or regulations to
23 the contrary, funds appropriated under this Act shall not be reprogrammed for any other
24 purpose.

25 **Section 5. Severability.** If any provision of this Act or the application of any such
26 provision to any person or circumstance should be held invalid by a court of competent

1 jurisdiction, the remainder of this Act or the application of its provisions to persons or
2 circumstances other than those to which it is held invalid shall not be affected thereby.


3 **Section 6. Savings Clause.** This Act and any repealer contained herein shall not be
4 construed as affecting any existing right acquired under contract or acquired under statutes
5 repealed or under any rule, regulation or order adopted under the statutes. Repealers contained
6 in this Act shall not affect any proceeding instituted under or pursuant to prior law. The
7 enactment of the Act shall not have the effect of terminating, or in any way modifying, any
8 liability, civil or criminal, which shall already be in existence on the date this Act becomes
9 effective.

10 **Section 7. Effective Date.** This Act shall take effect upon its approval by the
11 Governor or its becoming law without such approval.
