


Dear Governor Inos:

**HOUSE LOCAL BILL NO. 18-64, D1**

**A LOCAL APPROPRIATION BILL FOR AN ACT  
FOR THE THIRD SENATORIAL DISTRICT**

To appropriate the additional collections under Saipan Local Law No. 18-07 for activities within the Third Senatorial District; and for other purposes.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION  
PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1  
OF THE COMMONWEALTH CODE:**

1       **Section 1. Purpose.** The purpose of this Act is to appropriate the additional  
2 collections under Saipan Local Law No. 18-07 for activities within the Third Senatorial  
3 District.

4       **Section 2. Appropriations.** Notwithstanding any provisions, statutes, laws or  
5 regulations to the contrary, the Saipan and Northern Islands Legislative Delegation hereby  
6 appropriates the amount of \$387,000.00 from the additional collections under Saipan Local  
7 Law No. 18-07 as follows:

8           (a) \$60,000.00 for the CNMI Farmer's Cooperative Association for  
9 operations, under the expenditure authority of the President of the CNMI  
10 Farmer's Cooperative Association. The President shall submit an expenditure  
11 of funds report to the Chairman of the Saipan and Northern Islands Legislative  
12 Delegation thirty (30) days after the end of the fiscal year.

13           (b) \$34,000.00 for the repair and maintenance of the basketball court & social  
14 hall in Precinct II;

15           (c) \$34,000.00 to construct bus shelters and road bumps in Precinct V;

(d) \$34,000.00 to renovate the Health Center in Precinct IV;

(e) \$75,000.00 for the construction of Fitme Place road in Navy Hill, Saipan and for the inner road construction from the Garapan Fishing Base north to the Children's Park area by the Carolinian Affairs Office under the expenditure authority of the Secretary of the Department of Public Works.

(f) \$32,000.00 for the Office of the Mayor of Saipan for field operations equipment under the expenditure authority of the Mayor of Saipan. The Mayor of Saipan shall submit an expenditure of funds report to the Chairman of the Saipan and Northern Islands Legislative Delegation thirty (30) days after the end of the fiscal year.

(g) \$70,000.00 for various projects in Precinct 1;

(h) \$30,000.00 for the Public School System to procure school bus(es) under the expenditure authority of the Commissioner of Education. The Commissioner shall submit an expenditure of funds report to the Chairman of the Saipan and Northern Islands Legislative Delegation;

(i) \$18,000.00 for the Ayuda Network for personnel under the expenditure authority of the Secretary of Finance. The Secretary of Finance shall submit an expenditure of funds report to the Chairman of the Saipan and Northern Islands Legislative Delegation.

**Section 3. Reprogramming.** Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated under this Act shall not be reprogrammed for any other purpose.

**Section 4. Severability.** If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

**Section 5. Savings Clause.** This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained


1 in this Act shall not affect any proceeding instituted under or pursuant to prior law. The  
2 enactment of the Act shall not have the effect of terminating, or in any way modifying, any  
3 liability, civil or criminal, which shall already be in existence on the date this Act becomes  
4 effective.

5 **Section 6. Effective Date.** This Act shall take effect upon its approval by the  
6 Governor or its becoming law without such approval.
