
Dear Governor Torres:

HOUSE LOCAL BILL NO. 20-16

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate Ten Thousand Seven Hundred Fifty-Nine Dollars and Ninety-Two Cents (\$10,759.92) allotted under Saipan Local Law 19-08, and One Hundred Ninety Thousand Dollars (\$190,000.00) allotted under Saipan Local Law 19-23; and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION

PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1

OF THE COMMONWEALTH CODE:

SECTION 1. PURPOSE.

The purpose of this Act is to re-appropriate Ten Thousand Seven Hundred Fifty-Nine Dollars and Ninety-Two cents (\$10,759.92) allotted under Saipan Local Law 19-08 and One Hundred Ninety Thousand Dollars (\$190,000.00) allotted under Saipan Local Law 19-23.

SECTION 2. RE-APPROPRIATIONS.

Notwithstanding any provisions, statutes, laws or regulations to the contrary, the Saipan and Northern Islands Legislative Delegation hereby re-appropriates the following amounts:

(a) Ten Thousand Seven Hundred Fifty-Nine Dollars and Ninety-Two Cents (\$10,759.92) allotted under Saipan Local Law 19-08, for the paving of Toson Drive in Afetnas specifically as follows:

- (1) Five Thousand Six Hundred Twenty-Eight Dollars and Ninety-Two Cents (\$5,628.92) under BU 3753A; and

1 (2) Five Thousand One Hundred Thirty-One Dollars (\$5,131.00)
2 under BU 3753C.

3 (b) One Hundred Ninety Thousand Dollars (\$190,000.00) allotted under
4 Saipan Local Law 19-23, specifically:

5 (1) One Hundred Forty Thousand Dollars (\$140,000.00), under
6 BU 3753I, for the repair, drainage, and/or resurfacing of
7 Tuturam Road;

8 (2) Ten Thousand Dollars (\$10,000.00), under BU 3753I,
9 for the paving of Toson Drive in Afetnas; and

10 (3) Forty Thousand Dollars (\$40,000.00), under BU 3753J,
11 for the anti-skid pavement on As Perdido Road;

12 **SECTION 3. EXPENDITURE AUTHORITY.**

13 The expenditure authority for the funds under Section 2 of this Act shall be the
14 Secretary of the Department of Public Works.

15 **SECTION 4. REPROGRAMING.**

16 Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated
17 under this Act shall not be reprogrammed for any other purpose.

18 **SECTION 5. REPORTING.**

19 The expenditure authority shall submit to the Chairperson of the Saipan and Northern
20 Islands Legislative Delegation a detail report showing the expenditure of the funds at the
21 completion of appropriations in Section 2 of this Act.

1 **SECTION 6. FUND DISTRIBUTION.**

2 Funds appropriated under Section 2 of this Act shall be distributed accordingly to the
3 intended purpose and/or entity upon this Act becoming law.

4 **SECTION 7. FISCAL YEAR.**

5 The funds allocated under this Act shall be without fiscal year limitation(s).

6 **SECTION 8. SEVERABILITY.**

7 If any provision of this Act or the application of any such provision to any person or
8 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
9 Act or the application of its provisions to persons or circumstances other than those to which it
10 is held invalid shall not be affected thereby.

11 **SECTION 9. SAVINGS CLAUSE.**

12 This Act and any repealer contained herein shall not be construed as affecting any
13 existing right acquired under contract or acquired under statutes repealed or under any rule,
14 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect
15 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not
16 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which
17 shall already be in existence on the date this Act becomes effective.


1 SECTION 10. EFFECTIVE DATE.
