**A LOCAL APPROPRIATION ACT**

To appropriate the sum of Three **Hundred** Twenty Thousand Dollars **(\$320,000.00) from fees collected** under **Saipan Local** Law 11-2; and for other purpose.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4 OF DIVISION I OF TITLE 1 OF THE COMMONWEALTH CODE:**

Section 1. ~~Purpose~~ purpose of **this** Act is to appropriate Three Hundred Twenty Thousand Dollars **(\$320,000.00)** for the renovation and reconstruction of the pavilions in Precinct **III**, for Saipan's participant on the upcoming Mikronesian Games to be hosted in **Pohnpei** and for **waterline** distribution in Precinct **II**.


Section 2. **Appropriation.** There is hereby appropriated **\$320,000.00 from fees collected** under Saipan Local Law **11-2**, as follows: **\$30,000.00** for the renovation and construction of **recreation** or picnic pavilions in Precinct **III**, **\$50,000.00** for the upcoming Mikronesian Games, and **\$240,000.00** for waterline distribution in Precinct **II**.


Section 3. **Expenditure.** The sum authorized to be appropriated under this Act shall be expended by the **Secretary** of Public **Works for the renovation** and reconstruction of the pavilions in Precinct **III**, the **Secretary** of Community and **Cultural Affairs** for Saipan's participants on the upcoming **Mikronesian** Games, and the Acting Executive Director of the Commonwealth Utilities Corporation for the waterline **distribution** in Precinct **II**.

Section -4. Severability. **If** any **provision** of this **Act** or the application of any such provision to any person or circumstances should be, held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to **which** it is held invalid shall not be **affected** thereby.


Section 7. Effective Date. This Act **shall take effect** upon its approval by the **Governor** or upon its becoming law without such approval.
