**GENERAL ORDER NO. 2004-100**

**ORDER**

¶1 WHEREAS, on March 13, 2001, this Court issued General Order 2001-100 (hereinafter Order), adopting the public domain citation format recommended by the American Association of Law Libraries (AALL), as published in the Universal Citation Guide (1999)<sup>1</sup>, containing the following four elements without extraneous commas or periods: 1) the calendar year of issuance, 2) the geographic court designation of “MP”, 3) a sequential opinion number and, for pinpoint citations, 4) a paragraph number designating the precise location of the language cited; and

¶2 WHEREAS, 14 opinions issued in the year 1999, 18 opinions issued in the year 2000 and 2 opinions issued in the year 2001 were not assigned universal citations because they were issued subsequent to the publication of N.M.I. Reporter, Volume 5, but prior to the date the Order took effect.




