Bear Mr. President and Mr. Speaker:


I am pleased to inform you that I have signed into law Senate Bill No. 3-60, S.D.1, H.D.1, which was passed by the Third Northern Marianas Legislature.

Senate Bill No. 3-60, S.D.1, H.D.1 entitled, "An Act To amend Public Law 5-67 to provide that the Governor may appoint members to the Board of Directors of the Mariana Islands Housing Authority with the advice and consent of the Senate, and for other purposes," becomes Public Law No. 3-22.

This bill is important not only in bringing the appointment aspect into conformity with the Constitution and Public Law 1-8, but it will also give remedial accommodation to the codification process of our laws.


BE IT ENACTED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

1 Section 1. Section 4-1(a)(2) of Public Law 5-67 is amended to  
2 read as follows:


3 "(2) The Board members shall be appointed, and may be  
4 reappointed, by the Governor of the Northern Mariana Islands,  
5 with the advice and consent of the Senate."


6 Section 2. Effective Date. This Act sha'l take effect upon


