AN ACT

To re-appropriate fund balance from Public Law 11-79 to various road projects in Precinct I, and for other purposes.

BE IT ENACTED BY THE FOURTEENTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

**Section 1. Purpose.** The purpose of this Act is to re-appropriate certain fund balance remaining for the Third Senatorial District, the Nang Ocha Road under Public Law 11-79, to various road projects in Precinct I.

**Section 2. Appropriation Provision.** There is hereby appropriated the total amount of \$116,385.00 for road paving projects in Precinct I. The funding appropriated under this section shall be drawn from the following fund balance:

1. \$116,385.00 from road paving project of Section 6(c) (PL 11-79), continuation of Nang Ocha Road leading to Flores compound and other various road improvements in Precinct I.


**Section 3. Expenditure Authority.** The Secretary of Public Works shall be the expenditure authority for the funds appropriated under this act.


**Section 4. Severability.** If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

**Section 5. Savings Clause.** This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceedings instituted under or pursuant to prior


law. The enactment of this Act shall not have the effect of terminating, or in any way modifying liability, civil, or criminal, which shall already be in existence on the date this Act becomes effective.

**Section 6. Effective Date.** This Act shall take effect upon its approval by the Governor, or upon becoming law without such approval.
