without amendments in the form of H. B. 17-312 and transmitted to the

The Bill was not referred to a Senate Committee and was placed on the Bill Calendar
THE BILL WAS PASSED BY THE SENATE ON FIRST AND FINAL READING, AUGUST 29, 2012;
without amendments.

H. B. 17-312 WAS RETURNED TO THE HOUSE OF REPRESENTATIVES ON AUGUST 30, 2012.

H. B. 17-312

AN ACT

TO EXPRESS THE DESIRE OF THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS TO HAVE THE INSURANCE SYSTEM COMMONLY KNOWN AS "SOCIAL SECURITY" EXTENDED TO THE OFFICERS AND EMPLOYEES OF THE COMMONWEALTH GOVERNMENT AND ITS POLITICAL SUBDIVISIONS AND INSTRUMENTALITIES.

Be it enacted by the Seventeenth Northern Marianas Commonwealth Legislature:

1 **Section 1. Findings and Purpose.** The Legislature finds that the United States
2 Congress enacted Public Law 86-778 which excluded, upon certification, the officers and
3 employees of the government of Guam from participation in the insurance system commonly
4 known as "Social Security." This exclusion was extended to the Commonwealth
5 government. Employees in the private sector were not so excluded.

6 The Legislature finds that government employees often are employed outside of the
7 government upon separation from the government. The disparate systems often leads to
8 difficulties upon retirement, the very time when residents should be secure in their futures.

HOUSE BILL 17-312

1 The Legislature finds that it is now beneficial for the welfare of the residents of the
2 Commonwealth that the Commonwealth government participates in the insurance system
3 commonly known as "Social Security." The government's participation will reduce
4 operating expenses of the government and help ensure a stable retirement for the people of
5 the Commonwealth.

6 The Legislature finds and declares that this Act is necessary, and is a proper use of the
7 legislative authority granted by Article II of the Constitution of the Northern Mariana Islands.

8 **Section 2. Amendment.** Title 1 of the Commonwealth Code is hereby amended by
9 the inclusion of the following:

10 "(a) Statement of Intent. The Commonwealth of the Northern Mariana
11 Islands desires to have the insurance system established by Title II of the Social
12 Security Act extended to the elected officials and employees of the Commonwealth of
13 the Northern Mariana Islands and its political subdivisions and instrumentalities as
14 provided in 26 USC §3103 and §3111.

15 (b) Certification Required. No later than ten (10) days after the effective date
16 of this Act, the Governor shall certify to the Secretary of the Treasury of the United
17 States of America that this legislation has been adopted by the government of the
18 Commonwealth of the Northern Mariana Islands."

19 **Section 3 Severability.** If any provisions of this Act or the application of any such
20 provision to any person or circumstance should be held invalid by a court of competent
21 jurisdiction, the remainder of this Act or the application of its provisions to persons or
22 circumstances other than those to which it is held invalid shall not be affected thereby.


HOUSE BILL 17-312

1 **Section 4. Savings Clause.** This Act and any repealer contained herein shall not be
2 construed as affecting any existing right acquired under contract or acquired under statutes
3 repealed or under any rule, regulation, or order adopted under the statutes. Repealers
4 contained in this Act shall not affect any proceeding instituted under or pursuant to prior law.
5 The enactment of the Act shall not have the effect of terminating, or in any way modifying,
6 any liability, civil or criminal, which shall already be in existence on the date this Act
7 becomes effective.


HOUSE BILL 17-312

1 **Section 5. Effective Date.** This Act shall take effect upon its approval by the
2 Governor, or its becoming law without such approval.
