



without amendments and was returned to
THE HOUSE OF REPRESENTATIVES.

AN ACT

TO AMEND PUBLIC LAW 20-61 SECTION 2(C)(2) TO FUND THE PERSONNEL AND OPERATIONS OF THE TINIAN MUNICIPAL GOVERNMENT; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TWENTY-FIRST NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

1 **Section 1. Findings and Propose.** The Legislature finds that the Municipality of Tinian
2 and Aguiguan was severely impacted by a drop in revenue collections both locally and at the
3 CNMI level, resulting from the impact of Super-Typhoon Yutu. Accordingly, the Municipality
4 of Tinian and Aguiguan is in need of additional resources to be able to employ its employees for
5 the balance of Fiscal Year 2019.

6 The purpose of this Act is to amend Public Law 20-61 Section 2(c)(2) to fund the
7 personnel and operations for the municipal government of Tinian and Aguiguan; Tinian
8 Municipal Treasury employees; the Tinian Casino Gaming Control Commission personnel and
9 operations; and the Office of the Mayor of Tinian and Aguiguan.

10 **Section 2. Amendment.** Public Law 20-61 Section 2(c)(2) is hereby amended as
11 follows:

12 “(2) \$1,200,000 for the Second Senatorial District to fund the following:

1 (A) \$1,090,000 for personnel and operations, and public programs for the
2 municipal government of Tinian; Tinian Municipal Treasury employees; the Tinian
3 Casino Gaming Control Commission personnel and operations; and the Office of Mayor
4 of Tinian and Aguiguan under the expenditure authority of the Mayor of Tinian and
5 Aguiguan.

6 (B) \$60,000 for the procurement of one (1) van for the Office of Aging under the
7 Department of Community and Cultural Affairs-Tinian under the expenditure authority
8 of the Mayor of Tinian and Aguiguan;

9 (C) \$25,000 for the procurement of one (1) vehicle for the Division of Building
10 Safety under the Department of Public Works-Tinian under the expenditure authority of
11 the Mayor of Tinian and Aguiguan;

12 (D) \$25,000 for the procurement of one (1) vehicle for the Department of
13 Finance-Tinian under the expenditure authority of the Mayor of Tinian and Aguiguan.”

14 **Section 3. No Fiscal Year Limitation.** Notwithstanding any laws provisions or
15 regulations to the contrary, the funds appropriated under this Act shall be appropriated without
16 fiscal year limitation(s).

17 **Section 4. Management of Funds.** Notwithstanding any laws or regulations to the
18 contrary the Secretary of Finance shall transfer funds to the Tinian Municipal Treasury upon the
19 written request of the Mayor of Tinian and Aguiguan.

20 **Section 5. Severability.** If any provisions of this Act or the application of any such
21 provision to any person or circumstance should be held invalid by a court of competent
22 jurisdiction, the remainder of this Act or the application of its provisions to persons or
23 circumstances other than those to which it is held invalid shall not be affected thereby.

24 **Section 6. Savings Clause.** This Act and any repealer contained herein shall not be
25 construed as affecting any existing right acquired under contract or acquired under statutes
26 repealed or under any rule, regulation, or order adopted under the statutes. Repealers contained
27 in this Act shall not affect any proceeding instituted under or pursuant to prior law. The
28 enactment of the Act shall not have the effect of terminating, or in any way modifying, any

1 liability, civil or criminal, which shall already be in existence on the date this Act becomes
2 effective.

3 **Section 7. Effective Date.** This Act shall take effect upon its approval by the Governor,
4 or its becoming law without such approval.


