ADOPTION OF RULES AND REGULATIONS

OFFICE OF COASTAL RESOURCES MANAGEMENT

The Administrator of the Coastal Resources Management Office, after reviewing any and all comments received, hereby adopts the Coastal Resources Management Program Rules and Regulations as published in the Commonwealth Register on November 15, 1984, with the following amendment to Section 8(A)(v):


"v. Fees. CRM Permit applications shall be accompanied by a non-refundable CRM Permit application fee in accordance with the following schedule, by check made payable to the CNMI Treasurer.


- "(a) No fee for government projects.
- "(b) \$10.00 fee for minor permits and variances.
- "(c) For all others, the fee shall be as follows:

<u>"FEE AMOUNT</u>	<u>SIZE OF PROJECT</u>
"\$ 25.00	Under or equal to \$30,000
"\$ 75.00	Over \$30,000, but less than or equal to \$50,000
"\$150.00	Over \$50,000, but less than or equal to \$250,000
"\$200.00	Over \$250,000, but less than or equal to \$500,000
"\$275.00	Over \$500,000, but less than or equal to \$1,000,000
"\$350.00	Over \$1,000,000

"For each \$1 million increment in the cost/size of the project, there shall be assessed an additional fee of \$250.00."

According to law, these regulations shall take effect within ten (10) days of this public notice of adoption.

- "(c) Para i pumalo siha na planu, i presiu ma polo segun gi taiguine:




