NOTICE OF EMERGENCY AND PROPOSED REGULATIONS AMENDING CERTAIN SECTIONS OF THE COASTAL RESOURCES MANAGEMENT OFFICES RULES AND REGULATIONS RELATING TO THE SUBMISSION REQUIREMENTS FOR CRM MAJOR SITING APPLICATIONS.

The Administrator of Coastal Resources Management finds pursuant to 1 CMC Section 9104 (b) that the public interest requires the adoption before less than (30) thirty days notice of regulations modifying submission requirements for Coastal Resources Management Major Siting Applications. These amendatory regulations, which will take effect immediately, will allow the Coastal Resources Management Office to review CRM Major Siting Applications in a more timely, consistent and efficient manner, in accordance with applicable law.

These amendatory regulations are issued under the authority conferred by CNMI Public Law 3-47, Section (8)d, 1 CMC Section 9104 (b) and 1 CMC Section 9115.

EMERGENCY AND PROPOSED PERMANENT REGULATIONS AMENDING THE COASTAL RESOURCES MANAGEMENT OFFICE RULES AND REGULATIONS

Section 1. <u>Authority.</u> The Administrator of Coastal Resources Management, pursuant to his powers, duties and authorities under Public law 3-47, 2 CMC Section 1511 (3)B, as amended, issues the following amendments to the CRM Rules and Regulations to be published in the Commonwealth Register. These amendments shall take effect immediately pursuant to 1 CMC Section 9104 (b) and because they are also intended to be made permanent, shall be published in the Commonwealth Register.

- Section 2. <u>Purpose and Findings.</u> The Administrator finds the criteria of the current major siting submission requirements inconsistent with the public interest, unnecessarily burdensome on applicants, and of no practical assistance to the CRM permit evaluation process.
- Section 3. Section 8 (vii) (g) & (h) will be deleted and replaced and two new subsections "(u)" and "(v)" added all to read as follows:

<u>replacing condition (g)</u>

(g) The following construction plans;

1) Master site plan including; architectural features in conceptual form, major infrastructure and major amenities (in schematic or single line form).

2) Typical floor plans in conceptual format for all structures and major infrastructure.

3) View corridor plan

4) Site coverage plan - (displaying lot density including buildings, infrastructure, amenities, parking area, road networking and open space).

5) Proposed road improvements

6) Existing conditions map

- (h) The following erosion control and drainage plans;
 - a) Slope and elevation map
 - b) Watershed and drainage map
 - c) Preliminary drainage and erosion control map

The following new clause will be added as condition (u)

(u) The following plans shall be required of all applicants after the issuance of a CRM Major Siting Permit. The time frames for the submission of the plans shall be specified within the respective CRM permit conditions. Additional plans may also be required at the discretion of the CRMO Administrator or the CRM Board of Agency Directors. The requirement for such additional plans shall also be made a condition in the applicant's CRM permit.

1) Prints of 100% architecture and engineering drawings and specifications for the entire project certified by CNMI licensed architect and engineer.

2) Final plans for excavation, earthmoving and stormwater control.

3) Final master site plan

The following new clause will be added as condition (v)

(v) All dimensions shall be stated in English Units (ie. inches and feet)

PUBLIC NOTICE

NOTICE OF PROPOSED AMENDMENT TO REGULATIONS RESTRICTING THE ISSUANCE OF BUSINESS LICENSES TO GARMENT MANUFACTURERS, THE PROCESSING OF APPLICATIONS FOR WORK CERTIFICATES FOR ALIEN GARMENT WORKERS, AND THE ISSUANCE OF CERTIFICATES OF ORIGIN FOR GARMENTS PRODUCED IN THE CNMI.

These regulations are issued jointly by the Director of Commerce and Labor, The Attorney General, and the Director of Finance. They are issued under 1 CMC Section 9104 and the following authority:

1. Business Licenses: Director of Commerce and Labor has authority to license and regulate businesses under 1 CMC Section 2453 (d) and authority to promulgate regulations under 1 CMC Section 2454.

2. Labor Permits: Director of Commerce and Labor has authority to certify nonresident workers pursuant to 3 CMC Section 4435 (b) and authority to promulgate regulations under 3 CMC Section 4424(a).

3. Immigration Permits: The Attorney General has authority to certify nonresident workers pursuant to 3 CMC Section 4435 (b) and authority to promulgate regulations under 3 CMC Section 4331(a).

4. Certificates of Origin: The Director of Finance has authority to regulate customs pursuant to 1 CMC Section 2553 (i) and authority to promulgate regulations under 1 CMC Section 2557.

The proposed regulations would amend the rules and regulations promulgated on January 19, 1988 which establish a moratorium on the issuance of new business licenses for garment manufacturers, restrict certificates of origin to existing garment manufacturers, and limit the issuance of labor and immigration permits for nonresident workers under the classification of garment worker to the renewal of existing permits. The proposed amendments establish term "textile products", which eliminates textile а new manufacturers. The amendments would substitute this word throughout the regulations for the term "textile or textile products".

PROPOSED AMENDMENT

REGULATIONS RESTRICTING THE ISSUANCE OF BUSINESS LICENSES TO GARMENT MANUFACTURERS, THE PROCESSING OF APPLICATIONS FOR WORK CERTIFICATES FOR ALIEN GARMENT WORKERS, AND THE ISSUANCE OF CERTIFICATES OF ORIGIN FOR GARMENTS PRODUCED IN THE CNMI.

- Section 1. <u>Authority</u>. These regulations are issued under the joint authority of: (1) Commerce and Labor's jurisdiction over business licenses, 1 CMC Section 2453(d) and 1 CMC Section 2454; (2) Commerce and Labor's jurisdiction over labor permits for nonresident workers, 3 CMC Section 4435(b) and 3 CMC Section 4424(a); (3) Attorney General's jurisdiction over immigration of nonresident workers, 3 CMC Section 4435(b) and 3 CMC Section 4331(a); and (4) Finance's jurisdiction over customs, 1 CMC Section 2553(i) and 1 CMC Section 2557.
- Section 2. <u>Purpose of Regulations</u>. The purpose of these regulations is to amend the garment moratorium regulations to clarify that the restriction applies only to the manufacturers of textile products and not the manufacturers of textiles.
- Section 3. <u>Use of the Word "Regulations"</u>. The word "regulations", when used in the text of these regulations, shall refer to the joint regulations of the Department of Commerce and Labor, the Chief of Immigration, and the Director of Finance promulgated on January 19, 1988 in the Commonwealth Register and entitled "Adoption of Regulations Amending Regulations Restricting the Issuance of Business License to Garment Manufacturers and the Processing of Applications for Work Certificates for Alien Garment Workers".
- Section 4. <u>Amendment to Definition of "Garment Manufacturer"</u>. Section 2(d) of the regulations shall read as follows:

"Garment Manufacturer" means any sole proprietorship, partnership, corporation, firm, association or other group or combination engaged in the creation, production, or assembly of textile products.

Section 5. <u>Amendment to Definition of "Garment Worker"</u>. Section 2(e) of the regulations shall read as follows:

"Garment Worker" means any person, regardless of title, employed in the manufacture or assembly of textile products.

Section 6.

<u>Addition of Definition of "Textile Products"</u>. A new subsection (i) shall be added to Section 2, which shall read as follows:

"Textile Products" means all piece goods, made-up articles, garments, and other textile manufactured products (which are made in whole or in part from any natural or manmade fiber, or blend thereof) that are classified under Part 6, Schedule 3, Parts 1, 4, 5, 7, or 13 of Schedule 7, Part 1 of Schedule 8, or Part 1 of the Appendix to the Tariff Schedules of the United States (19 U.S.C. 1202). This does not include fibers or yarns under Schedule 3, Part 1, TSUS.

Section 7. <u>No Further Amendments Intended</u>. No further amendments are intended. The remainder of the regulations shall continue in force and effect subject to these changes.
