NOTICE OF PROPOSED AMENDED POLICIES



## 3200 POSITION & APPOINTMENTS

### 3203(C) Non-Certified Appointment

- C. A non-certified appointment is one in which the appointee is appointed for a period of not to exceed ~~one (1) year~~ two (2) years. An employee serving a non-certified may serve in either a full-time or part-time position. Any person given a non-certified appointment must meet the minimum qualifications for the class of position to which appointed.

### 3203 Types of Appointments

3203(F) The school principal and program manager must prepare a recommendation letter for respective employee(s) contract renewal and forward it to the staff services office at least three (3) months prior to the employee's contract expiration date. The term of renewal of the contract will be determined by the school principal or the program manager but not to exceed two years. Renewal of the contract is wholly within the discretion of the employer, based on the employee's satisfactory job performance and the employment needs of the employer.

3203(G) All teachers on 190-Day Contract may elect to receive lump-sum payment on unused personnel leave at the end of each school year.

### 3206 Reinstatement

An employee may be reappointed to his former position in the Public School System at the same pay level and step that he held upon his separation within a five (5) year period. If re-appointed to a higher or a lower class, he may be allowed to retain his former rate of pay. The possession of reinstatement eligibility does not thereby provide the person with any mandatory reemployment rights. This means that the individual may be considered for employment only after persons with higher rating on the reemployment priority list have been considered. If it is in the Public interest, such person may be reemployed, provided he meets the noncompetitive qualifications for the position to be filled.

### 3401(A) Separation Not Involving Personal Cause

- A. Resignation. Resignation shall be in writing and shall be submitted at least ~~ten (10)~~ thirty (30) working days in advance of the effective date.

## 4200 COMPENSATION

### 4204 Establishing Salary Upon Appointment

Salary shall be fixed at the first step of the appropriate pay level upon initial appointment. Should a higher rate be deemed necessary to recruit, and is appropriate to the qualification of the applicant, the salary may be fixed at any succeeding steps but not beyond the fifth step provided it is within the budgeted level of the position. Payment of salary above Step 1 of a pay level must be approved by Commissioner of Education.

**4211 Reallocation/Reclassification of Position to Higher Pay**

An employee whose position is reallocated/reclassified to higher class shall be compensated at the lowest step in the higher pay level which at least equals the amount of two (2) steps increase in the lower (present) pay level. The rate of compensation cannot exceed the rate of the maximum step in the higher pay level. The anniversary date of the new reallocation/ reclassification shall be recycled.

**4213(A) With-in-Grade Increase**

With-in-grade increase may be granted upon completion of fifty-two (52) calendar weeks of satisfactory performance. The evaluation and with-in-grade increase form shall be completed by the immediate supervisor or his designee's within five working days following the effective date.

**4215(A) Overtime Compensation, Compensatory Time & Control**

- A. Any employee who is directed to work and does work in excess of forty (40) hours a week shall be paid overtime at the rate of one and one-half (1 1/2) times his basic pay; or in the absence of any funds for overtime compensation, compensatory time-off shall be granted ~~within four (4) pay periods from the date in which it was earned, and any compensatory time not used within a four pay period interval shall be converted to overtime pay the following pay period any period of time.~~ All employees including those in an executive administrative or professional capacity may earn compensatory time which has no monetary value not to exceed 120 hours. Employees who are in 190 Day Contract are not eligible to earn or to use compensatory time.

PROPOSED REGULATIONS TO DELETE THE CHALAN LAULAU  
EXCLUSION AREA FROM THE JET-SKI REGULATIONS

Section 1. Authority. The Administrator of Coastal Resources Management, pursuant to its powers, duties and authorities under Public law 3-47, 2 CMC Section 1511 (3)B, as amended.

Section 2. Purpose and Findings. The Administrator finds that several permit applications for Jet-Ski operations are pending and the Chalan Laulau shoreline is suitable for such operations. Therefore, in order to accommodate the demand for operational areas, the Chalan Laulau Exclusion Area will be deleted.

Section 3. Section I 102. (F) only

102. Exclusion Areas

No jet ski may be landed, launched or operated within the following areas:

**TO BE DELETED - (F) only**

F. Chalan Laulau:

An area extending 200 yards seaward from the mean low water line from the northern edge of Civic Center Beach north to the Garapan Fishing Center dock.

The Board of Trustees for the Northern Mariana Islands Retirement Fund promulgates these amendments to the rules and regulations pursuant to 1 CMC Section 8316(f), and the Administrative Procedures Act, 1 CMC 9101, et. seq.

## PART I. AUTHORITY

Section 1. Authority. Under and by virtue of the provisions of 1 CMC Section 8316(f), the Board of Trustees for the Northern Mariana Islands Retirement Fund hereby promulgates these amendments to the rules and regulations.

## PART II. AMENDMENT

Section 1. Amendment. To amend Part 2(k) of the Fund's Administrative Rules and Regulations to read as follows:


(k) "*Complete Separation from Service*" means separation from government service by any employee of the Commonwealth Government, including its agencies and instrumentalities, whose employment is terminated and is not reemployed by any branch of the Commonwealth Government, including its agencies and instrumentalities within seven (7) days from the date of termination.

(i) Any employees who has separated from service and has obtained a refund of contributions, and is reemployed by the Commonwealth Government, including any of its agencies and instrumentalities within seven (7) days after such separation, shall return to the Fund any refunded contributions received within 30 days of reemployment.

(ii) If the contributions have not been refunded, the employee who returns to government employment within 7 days from the date of last termination shall retain the same membership class as when last terminated.

AMENDING COASTAL RESOURCE MANAGEMENT OFFICE  
RULES & REGULATIONS FOR GRANTING CRM MAJOR SITING  
PERMIT HOLDERS TIME EXTENSIONS**


Section 12 (C)(ii) - new section to replace existing section:

Timing and Duration. Permitted physical development of the project site subject to a CRM Permit shall begin within the time frame specified for project commencement on the permit. The maximum time limit allowed for project commencement shall be one (1) year. The project shall be completed within the time frame specified on the permit for project completion. The maximum time limit allowed for project completion shall be three (3) years unless it can be demonstrated the scope of the project requires additional time for construction purposes(only). Upon project completion, the permittee shall deliver a Completion Certificate to the CRM Office. If the project is not completed within the time frame specified in the permit, the permit will be reviewed by the CRM Administrator who will do one of the of the following: 1) extend or amend the permit or 2) terminate the permit. If the CRM Administrator grants an extension of the permit, a fee equaling fifty percent (50%) of the original permit fee shall be assessed. The CRM Administrator shall have the discretion to waive this fee if the project has been substantially completed. Substantial completion means, the project is over seventy-five (75%) structurally complete as certified by a CNMI registered Architect or Engineer.

All conditions attached to the permit shall be of perpetual validity unless action is taken to amend, suspend, revoke or otherwise modify the CRM Permit.


