6 Accordingly, upon vote of the Commission at the duly noticed public hearing of
7 today's date, Provisional Casino Vendor license number CCC-PVCL-2016-012 is
8 REVOKED. Further, the Commission DENIES Respondent's application for Casino Vendor
9 License submitted to the Commonwealth Casino Commission on or about February 1,
10 2017. Respondent is ORDERED to pay a fine of One Hundred Fifty Thousand Dollars
11 (\$150,000.00) on or before December 31, 2017.
