

HOUSE LOCAL BILL NO. 18-67, D1

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE FIRST SENATORIAL DISTRICT**

To appropriate \$9,000.00 from local license fees collected for poker and pachinko slot machines in the First Senatorial District; and for other purposes.

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION
PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1
OF THE COMMONWEALTH CODE:**

1 **Section 1. Purpose.** The purpose of this Act is to appropriate the amount of \$9,000.00 from
2 local license fees for poker and pachinko slot machines collected pursuant to 10 CMC §1901 to
3 activities for the First Senatorial District. The Commonwealth Legislature enacts this legislation under
4 its authority in Article II, Sections 1 and 6 of the Constitution of the Northern Mariana Islands. The
5 First Senatorial District Delegation finds that there is a need to provide a subsistence allowance for
6 residents of the First Senatorial District who are undergoing dialysis and treatment for terminal illnesses
7 outside of the First Senatorial District.

8 **Section 2. Appropriations.** The amount of \$9,000.00 is appropriated from local license fees
9 for poker and pachinko slot machines collected pursuant to 10 CMC §1901 for the following purposes:

10 (a) \$9,000.00 to the Department of Finance for the purpose of providing a
11 monthly subsistence allowance for residents for the First Senatorial District who are
12 undergoing dialysis treatment and treatment for terminal illnesses outside of the First
13 Senatorial District. The monthly subsistence allowance for September 2014 shall be partially
14 paid and not to exceed \$200.00.

15 **Section 3. Expenditure Authority.** The expenditure authority for subsection 2 (a) shall be
16 the Secretary of Finance.

17 **Section 4. Reprogramming.** Notwithstanding any provisions, laws to the contrary, funds
18 appropriated under this Act shall not be reprogrammed for any other purposes.

1 **Section 5. Severability.** If any provision of this Act or the application of any such provision
2 to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder
3 of this Act or the application of its provisions to persons or circumstances other than those to which it is
4 held invalid shall not be affected thereby.


5 **Section 6. Savings Clause.** This Act and any repealer contained herein shall not be construed
6 as affecting any existing right acquired under contract or acquired under statutes repealed or under any
7 rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any
8 proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect
9 of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in
10 existence on the date this Act becomes effective.

11 **Section 7. Effective Date.** This Act shall take effect upon its approval by the Governor or
12 its becoming law without such approval.


