HOUSE LOCAL BILL NO. 18-55

A LOCAL BILL FOR AN ACT FOR THE THIRD SENATORIAL DISTRICT

To amend the Saipan Zoning Law of 2013, 10 CMC § 3511 to include funeral homes as a conditional use in Village Commercial Zoning Districts.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION

PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1

OF THE COMMONWEALTH CODE:

Section 1. <u>Findings</u>. The Saipan and Northern Islands Legislative Delegation finds that it is appropriate to allow funeral homes to be a conditional use in zoning districts designated Village Commercial.

Section 2. <u>Amendment</u>. Section 3. Amendment. Section 404, Table 1 of the Saipan Zoning Law of 2013 incorporated by 10 CMC § 3511, is hereby amended as follows:

"The use, 'Funeral Homes' is to have a 'c' for conditional use in the column for 'Village Commercial'."

Section 3. <u>Severability</u>. If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

Section 4. <u>Savings Clause</u>. This Act and any repealer contained herein shall not be
construed as affecting any existing right acquired under contract or acquired under statutes
repealed or under any rule, regulation or order adopted under the statutes. Repealers contained

in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

Section 5. <u>Effective Date</u>. This Act shall take effect upon its approval by the Governor or its becoming law without such approval.
