AN ACT

To designate certain days of each year as legal holidays.

	BE IT ENACTED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:	
1	Section 1. The purpose of this Act is to designate certain days of	
2	each year as legal holidays for the recognition and celebration of the	
3	most important historical events in the Northern Mariana Islands.	
4	Section 2. In addition to the federal holidays observed, the	
5	following days of each year are hereby declared as legal holidays for	
6	the Commonwealth of the Northern Mariana Islands:	
7	(a) January 9 Commonwealth Day;	
8	(b) March 24 Covenant Day; and	
9	(c) December 8 Constitution Day.	
10	Section 3. On each holiday of the year all government employees	
11	shall receive leave with pay. All employees who are required to work	
12	on any such day shall be paid double his or her regular salary.	
13	Section 4. If a holiday falls on a Saturday, it shall be	
14	celebrated on the previous day. If a holiday falls on a Sunday, it shall	
15	be celebrated on the following day.	
16	Section 5. This Act shall take effect upon its approval by the	
17	Governor, or upon its becoming law without such approval.
