AN ACT

To name the Rota Public Library building located in Songsong Village on the island of Rota "Antonio Camacho Atalig Memorial Library" in honor of the late Mayor Antonio Camacho Atalig of Rota.

BE IT ENACIED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

Section 1. The Rota Public Library building located in Songsong Village on the island of Rota is hereby named "Antonio Camacho Atalig Memorial Library".

Section 2. The Mayor of Rota shall designate a day for a ceremony to be held whereby he shall officially name the library as set forth in Section 1 of this Act.

Section 3. This Act shall take effect upon its approval by the Governor, or upon its becoming law without such approval.
