THIRD REGULAR SESSION, 1983

AN ACT

To amend Section 402 of Public Law 3-11 as amended to provide that the general excise tax shall not apply to capital inventory machinery and raw materials used in manufacturing businesses.

BE IT ENACTED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

1	Section 1. Section 402 of Public Law 3-11, as amended is amended
2	to add a new subsection (i) to read as follows:
3	"(i) Capital inventory machinery with a fair
4	market value exceeding \$1,000 and raw materials
5	used in businesses primarily engaged in
6	manufacturing for export shall be exempt from
7	the excise tax imposed by this Section 402."
8	Section 2. Effective Date. This Act shall take effect upon its
9	approval by the Governor, or upon its becoming law without such approval.
