Dear Mr. President and Mr. Speaker:

This is to inform you that I have signed into law Senate Bill No. 5-98, entitled, "To declare November 4 of each year as a legal holiday to be known as Citizenship Day, in recognition of the fact that on that day in 1986 the Covenant to Establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America goes into full force and effect and the people of the Northern Mariana Islands become citizens or nationals of the United States, thereby realizing the aspiration of nearly forty years for political self-determination, to repeal and reenact Section 311 of Title 1 of the Commonwealth Code, as amended, and for other purposes," which was passed by the Fifth Northern Marianas Commonwealth Legislature.

This bill is one of the most significant legislation since the inception of the Commonwealth.

We had anticipated that the Termination of the Trusteeship would take place during 1981. It has been long overdue.

Today marks a milestone in the history as our citizens are now full-fledged citizens or nationals of the United States and are able, for the first time, to receive the benefits contained in the Covenant.

For the reasons, stated above, I am extremely pleased to affix my signature to this bill which will make Citizenship Day a legal holiday in the Northern Mariana Islands.

This bill becomes Public Law No. 5-21. Copies bearing my signature are forwarded for your reference.

TO DECLARE NOVEMBER 4 OF EACH YEAR AS A LEGAL HOLIDAY TO BE KNOWN AS CITIZENSHIP DAY, IN RECOGNITION OF THE FACT THAT ON THAT DAY IN 1986 THE COVENANT TO ESTABLISH A COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS IN POLITICAL UNION WITH THE UNITED STATES OF AMERICA GOES INTO FULL FORCE AND EFFECT THE PEOPLE OF THE NORTHERN MARIANA ISLANDS BECOME CITIZENS OR NATIONALS OF THE UNITED STATES, THEREBY REALIZING THE ASPIRATION OF NEARLY FORTY YEARS FOR POLITICAL SELF-DETERMINATION, TO REPEAL AND REENACT SECTION 311 OF TITLE 1 OF THE COMMONWEALTH CODE, AS AMENDED, AND FOR OTHER PURPOSES.

#### AN ACT

To declare November 4 of each year as a legal holiday to be known as Citizenship Day, in recognition of the fact that on that day in 1986 the Covenant to Establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America goes into full force and effect and the people of the Northern Mariana Islands become citizens or nationals of the United States, thereby realizing the aspiration of nearly forty years for political self-determination, to repeal and reenact Section 311 of Title 1 of the Commonwealth Code, as amended, and for other purposes.

## BE IT ENACTED BY THE FIFTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

- 1 Section 1. Findings. The Legislature finds that November 4 of
- 2 1986 will be an historic occassion that should be commemorated annually
- 3 as holiday. On that day, nearly forty years of aspiration by the people
- 4 of the Northern Mariana Islands to join the American political family as
- 5 a self-governing Commonwealth, become citizens or nationals of the United
- 6 States, and end 400 years of foreign domination will finally be realized.
- 7 This is an event that has been long-awaited and cause for Commonwealth-
- 8 wide celebration.
- 9 Section 2. Designation of Legal Holiday. The fourth day of
- 10 November of each year is hereby declared a legal holiday in the
- 11 Commonwealth, to be known as Citizenship Day.
- Section 3. Repeal and Reenactment. Section 311 of Article 1 of
- 13 Chapter 3 of the General Provisions of Title 1 of the Commonwealth Code,
- 14 as amended, is repealed and reenacted as follows:
